

IMPORTANT NOTICE ABOUT ONLINE TRANSFERS

By now, you have likely received information pertaining to the upcoming Accounts System Conversion weekend when we will transition all WSBT member accounts onto the LLCU accounts system. With this conversion, WSBT Online and Mobile Banking will be discontinued and you will need to re-enroll in LLCU Online Banking beginning Monday, Sept. 28th at 8:00a.m.

Due to WSBT Online Banking being discontinued after 9/25/26 at 2:00p. m. – please make note of the following important information about a service that will be impacted:

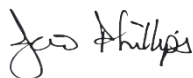
Any scheduled transfers created in WSBT Online Banking with an effective date of ON OR AFTER 9/24/2026 will not occur.

Beginning on Monday, 9/28/2026 at 8:00a.m., you will need to re-enroll in LLCU Online Banking and once enrolled, you will need to reschedule your transfers.

To prepare for rescheduling your transfers, we recommend that you log in to WSBT Online Banking BEFORE 9/25/26 at 2:00p.m. and print your Account Statement to have a record of recurring transfers that will need to be rescheduled once enrolled in LLCU Online Banking. We have provided instructions on the reverse side of this letter to guide you through how to print your statement, as well as how to enroll in LLCU Online Banking.

STEPS TO PRINT STATEMENTS in WSBT ONLINE BANKING
Must be done PRIOR to 9/25/26 at 2:00PM

TO PRINT STATEMENTS IN WSBT ONLINE BANKING:

1. Go to “Accounts” and click “Statements”.
2. Select the account you desire a statement for using the down arrow.
3. Choose the account & then choose statement date you wish to view.
4. A pop-up box will appear (*the box will look blank*).
5. On top right corner, choose “SAVE: or “PRINT” and the statement will appear.
6. Repeat steps 1-5 to collect any other statement dates you wish to have.

STEPS TO ENROLL IN LLCU ONLINE BANKING
BEGINNING 9/28/26 at 8:00AM

TO ENROLL IN LLCU ONLINE BANKING:

1. Before you begin enrollment, you will need to confirm that we have your current mailing address, phone, and email address on file.
2. Visit www.llcu.org on your desktop computer.
3. On the LLCU homepage, scroll to “LLCU Online Banking” and click the “LOGIN” button.
4. On the next screen, enter the same User ID you previously used to login to WSBT Online Banking.
5. For the Password, use the **LAST SIX DIGITS of YOUR SOCIAL SECURITY NUMBER** as your temporary password.
6. Click “Log In” and follow the prompts to reset your password. **Make note of your user ID and password as these will be the same for Mobile Banking.*

Friday, September 25th <i>Beginning at 2:00p.m.</i>	The Springfield, Williamsville & Sherman LLCU branches will close early at 2:00p.m. WSBT Online Banking will no longer be available beginning at 2:00p.m.
Saturday, September 26th Sunday, September 27th	ALL LLCU Branches will be CLOSED & LLCU ONLINE BANKING UNAVAILABLE.
Monday, September 28th	ALL LLCU Branches will re-open with regular business hours. LLCU Online Banking will be restored. WSBT Members should activate and begin using their new LLCU debit card. WSBT Members should login and enroll in LLCU Online Banking.
